## **DISINFECTING KOROSEAL PRODUCTS**



The U.S. Environmental Protection Agency (EPA) publishes a list of registered disinfectants on the EPA's List N: "Products for use against SARS-CoV-2" that meet the EPA's criteria for use against SARS-CoV-2, the virus that causes COVID-19. The U.S. Centers for Disease Control (CDC) provides guidelines to clean surfaces with soap and water and then disinfect surfaces with a diluted bleach solution – 1/3 cup bleach per gallon of water.

The following list (in the chart below) of disinfectants on EPA List N and the CDC recommended bleach solution were tested on the Koroseal products noted in the chart. The results of these tests showed no evidence of damage or discoloration to the products designated with a " $\checkmark$ ".

Koroseal performed five (5) repeated stain tests by applying the applicable disinfectant to the surface, exposing as per EPA and CDC requirements for the product to kill SARS CoV-2 and wiping with a soft cloth and water and then dried. Koroseal will continue to update this document as additional disinfection solutions are tested.

Purtabs (sodium troclosene) is not published on the EPA List N at this time but has been tested with no evidence of damage or discoloration to any of the products listed above. Virex® Tb (quaternary ammonium) is not published on the EPA List N at this time but has been tested with no evidence of damage or discoloration to all Korogard, Walltalkers, and Reatec Architectural Film products listed above.
